

ST. BENEDICT AT AUBURNDALE 2024-2025 TUITION



- Traditional Program: \$15,725*
- PLUS Program: \$16,800*

*Above tuition includes all fees (activity, technology, course, drug testing) except for:

- Class of 2025 Graduation \$200 (Seniors Only)
- AP / Capstone Testing Registration and ACT Testing
- Textbooks
- Extracurricular Activities (Sports & Clubs) /Field Trips
- Dining Fees (Breakfast, Lunch, Snacks)
- Bus Transportation

Tuition deposit of \$250 is required upon enrollment to reserve your child's spot and schedule for the 2024 - 2025 school year. Families that enroll within 14 days of receiving their enrollment link will have their \$150 enrollment fee waived.

Tuition Payments and FACTS

All families are required to be enrolled with FACTS Tuition Management for processing of tuition payments. Laptops **will not** be distributed to students until this is completed.

- **NEW** families can enroll at <https://online.factsmgt.com/signin/3CF1Q> to set up your family's plan. You will customize your plan and select the date and frequency of your billing to match your family budget.
- **Current** families that already have an SBA FACTS agreement will be re-enrolled for the 2024-2025 school year with the same plan as originally selected. If you need to revise your plan, please call Kathy Hurt at 260-2868 in the Business Office to submit your request.
- Families are responsible for the annual sign-up fee charged by FACTS. The sign-up fee will be scheduled on the confirmation email you receive from FACTS after your agreement is finalized. The payment will be due within 14 days of your agreement being finalized.
- Payment Plans
 - Annually – All monies are due April 1, 2024 (\$200 Discount)
 - Quarterly – Due dates: May, August, November, February
 - Monthly – The monthly payment plan options are as follows:
 - 12-month plan: payments are due April 2024 - March 2025
 - 11-month plan: payments are due May 2024 - March 2025
 - 10-month plan: payments are due June 2024 - March 2025

All monthly payment plans must be paid in full by March 2025.

Tuition Discounts

- Annual Payment Option: A \$200 discount will be given if the Business Office is notified by **March 21, 2024** and tuition is paid in full by **April 1**.
- **Multi Child Rate:** A \$200 discount will be given for each additional sibling enrolled.

FACTS Incidental Billing

Incidental Billing offers the flexibility and convenience for families to pay for incidental expenses that fall outside of tuition (i.e. AP testing, bus fees, etc.). Incidental invoices may be sent periodically for charges that are not included in your payment plan with FACTS.

It's important to note the difference between your *tuition payment plan* and *billing for incidental fees*:

The incidental fees are various fees billed separately and will never be added to or subtracted from your tuition payment plan.

To activate your incidental billing, please review and/or activate autopay.

Families may also add the FACTS Peace of Mind (POM) benefit. This optional benefit is added to the FACTS enrollment fee. In the event of the death of a parent/guardian, FACTS will cover the student's tuition for the rest of the academic year.

RELATED POLICIES

Re-Enrollment - The Catholic Diocese of Memphis requires that all financial obligations must be current for students to re-enroll at St. Benedict.

Enrollment Contract – The Enrollment Contract is included on the student's online Enrollment Form. All parents/guardians will agree to the Enrollment Contract with their electronic signature, and understand that, **unless the SBA business office is notified in writing to cancel this contract with fourteen (14) calendar days of submission, the parents/guardians financially responsible for the student will be obligated to pay the full annual tuition charges and fees.**

Credit Card usage –All credit card transactions to be charged an additional 4.0%.
